WAIVER AND RACE PARTICIPATION AGREEMENT

1. I acknowledge that long distance running involves the real risk of serious injury or even death from various causes including overexertion, dehydration, accidents with other competitors, spectators or other road/trail users, course or weather conditions and other causes.

2. I understand that I should not compete in this event unless I have trained appropriately and, should I become injured prior to the event, then I shall withdraw from the event.

3. I understand, that should I feel unwell or show any signs of symptoms relating to the COVID-19 virus that I should not attend the event in any capacity; either as a spectator or athlete.

4. By competing, I accept all risks necessarily flowing from my participation that could result in loss of life or permanent injury. Accordingly, I release all persons or corporations associated directly or indirectly with the conduct of the event from all claims, demands and proceedings arising out of my participation and I hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my participation in this event. This release shall extend to and include Australian Ultra Runners Association Inc. (AURA) and its respective directors, partners, managers, officers, agents, contractors, employees and volunteers including medical and paramedical personnel appointed for the event, the owners, licensees and occupiers of land upon which the event or any part of it is conducted, any statutory body or local authority having control over any land upon which the event or any part of it is conducted or which is involved directly or indirectly with the event in any manner whatsoever and promoters, sponsors and event organisers. This release and indemnity continue forever and binds my heirs, executors, personal representatives and assigns.

5. I consent to receiving any medical treatment including ambulance transportation that the event organisers consider appropriate during or after the event and take all responsibility therefor.

6. I consent to Sport 3 Event Management Pty Ltd and the event sponsors using my name, image and likeness before, during or after the event for event promotional broadcasting or reporting purposes in any media.

7. I understand that safety precautions undertaken by organiser/s (such as course supervision, gear checks and race safety briefings) are a service to me and other competitors but are not a guarantee of safety.

8. I am fully responsible for the security of my personal possessions at the event.

Cancellation by You

9. If I am unable to compete for any reason my registration fee is non-refundable. My registration however can be transferred as a credit to a future Sport 3 Event Management event if I request this in writing before midnight Friday 24th November 2023, subject to a \$20 admin fee.

Please also note: My registration may only be transferred to a future event on one occasion. When my registration has been transferred once, it is then non-transferrable.

10. My registration may also be transferred to another runner if I request this in writing before midnight Friday 10th November 2023, subject to a \$20 admin fee.

11. No changes are permitted to my race entry after midnight Friday 17th November 2023, with the exception of distance changes - subject to availability.

12. Complimentary registrations are non transferrable. This includes both 'transfers between people' and 'transfers to a future event'.

Cancellation by Organiser

13. Should the event be postponed my registration will be automatically transferred to the re-scheduled event date where the following refund policy will apply:

13a. I will be entitled to a refund of my registration (less payment processing fees) if I request this in writing within 72 hours of being notified of the postponement. Should I not request a refund during this 72-hour period my registration will revert back to being non-refundable.

14. Should a new date not be possible for the event to occur, my entry will be transferred into the 2024 event and the above cancellation procedures regarding refunds will apply.

14b. Should you be unable to attend the event due to international or inter-state border restrictions you will be eligible to receive a refund of your registration (less payment processing fees) or alternatively transfer your entry to 2024. Standard proof of address is requested in this scenario.

15. You agree that we will have no other liability to you in respect of a cancellation other than these refund options. Sport 3 Event Management are not responsible for any incidental expenses that you may have incurred in connection to your booking including but not limited to travel expenses such as non-refundable flights or accommodation.

16. I have informed or will inform the race organiser/s of any medical or physical conditions from which I suffer that might be relevant in affecting my performance or might be relevant if medical treatment is required.17. I agree to abide by the race rules and directions issued by the event organiser/s.

18. The event organisers may change the race format, course or other race conditions at their discretion. Should such change occur then this agreement applies to the changed conditions.
